Article 9. Through the Proposal to amend the Company's Charter. Including the amendment to Article 3 regarding the Company's legal representative: the Company has one legal representative, who is the Chairman of the Board of Directors.

Article 10. Through the Proposal for the issuance of shares to pay dividends to existing shareholders .

Article 11. Through the Proposal for a plan to offer additional shares to the public for existing shareholders to increase charter capital.

Article 12. Through the Proposal regarding dismissal of the Board of Directors' members of the 2021-2025 termperiod, and election of the Board of Directors' members for the 2026-2030 termperiod.

Article 13. Through the Proposal regarding dismissal of the Board of Supervisors' members of the 2021-2025 termperiod, and election of the Board of Supervisors' members for the 2026-2030 termperiod.
